



## **Private Water Quality Facility Management Program (PWQFMP) Landscape Contractor Application**

Clean Water Services and its member Cities have implemented the Private Water Quality Facility Management Program to help ensure that privately-owned water quality facilities are properly maintained to function as designed. There are more than 1,000 such facilities within our jurisdictions. We are compiling a list of landscape contractors that agree to perform maintenance according to the criteria adopted by Clean Water Services. The list will be a resource for owners and managers of privately-owned water quality facilities in Washington County and parts of Clackamas and Multnomah Counties.

To apply, a Contractor must:

1. Provide two references for work performed on vegetated water quality facilities within Clean Water Services' jurisdiction.
2. Be licensed in the State of Oregon.
3. Follow Clean Water Services' Integrated Pest Management Guidance (IPM) for invasive vegetation, insect and rodent control.
4. Follow preferred maintenance practices as specified in the Private Water Quality Facility Management Program (PWQFMP) Inspection Guide.
5. Complete the application form and submit required information. Items 3, 4 and 5 available at [cleanwaterservices.org](http://cleanwaterservices.org).

***Contractors accepted for the list must comply with the practices set forth in the IPM or PWQFMP Inspection Guide. Failure to comply will result in removal from the list for six months, after which the Contractor may re-apply.***
