HOLD A PUBLIC HEARING AND ADOPT REVISED DESIGN AND **CONSTRUCTION STANDARDS**

SUMMARY

Clean Water Services (District) has completed revisions to its Design and Construction Standards (Standards). These regulations, which set the minimum standards for construction of components of the sanitary sewer and storm and surface water management systems within the District's boundary, are adopted pursuant to Ordinance 27. The District's last comprehensive update to the content of its Standards occurred in April 2007, with the adoption of Resolution and Order (R&O) 07-20. Additional minor revisions were made in 2008 with the adoption of R&O 08-28 and in 2009 with the adoption of R&O 09-25.

HOLD A PUBLIC HEARING AND ADOPT REVISED DESIGN AND CONSTRUCTION STANDARDS 03/28/17

The proposed changes include revisions necessary to meet the requirements of the District's new National Pollutant Discharge Elimination System Watershed-Based Permit (NPDES Permit), particularly as they relate to providing stormwater treatment for projects disturbing 1,000 square feet or more and to the prioritization of Low Impact Development Approaches (LIDA) on development sites. Proposed changes also address how treatment will be approached on redevelopment sites and include minor revisions to address new technology in the standard details, erosion control, and pump stations sections, and minor housekeeping changes throughout the document.

The District's NPDES Permit requires that the new Standards be adopted and effective by April 22, 2017, which is the first anniversary of the issuance of the NPDES Permit. The Standards will become effective for new applications received on or after April 22, 2017.

A comprehensive public involvement process was completed to review the proposed changes. Notices of meetings and interim drafts of the proposed changes were sent to a list of over 350 stakeholders from the development, builder, engineering, and environmental communities, as well as the County and City co-implementers, Tualatin Hills Park and Recreation District, and Community Participation Organization representatives. Background papers, draft changes, Clean Water Services Advisory Commission (CWAC) presentations, public comments and supporting documents were posted on the Clean Water Services website as they became available. Three presentations were made to CWAC. A separate email account (dncupdate@cleanwaterservices.org) was established to receive comments and feedback. Written comments were received from 17 entities, a number of whom submitted multiple comments. Approximately 80 people attended three public meetings held in September 2016, October 2016 and January 2017.

Notice of the final language proposal and this public hearing was published in local newspapers and individually sent to involved stakeholders during the week of March 20, 2017.

PHASE 1 UPDATE TO DESIGN AND CONSTRUCTION STANDARDS

Overview of Changes by Chapter

As part of the Phase 1 Design and Construction Standards Update, Clean Water Services (District) has drafted proposed changes that incorporate new NPDES permit requirements and reflect new technologies, approaches and development patterns. Specific changes are summarized by chapter below and described in detail by Reader Notes in each chapter.

Chapter 1, General Requirements and Administrative Provisions

- Add and revise definitions to comply with new permit conditions and maintain consistency.
- Add definitions for the following terms: Modified, Water Quality or Quantity Approaches, Water Quality or Quantity Facilities.
- Revise definitions for the following terms: Impervious Surface, Low Impact Development Approaches and Redevelopment.

Chapter 2, Administrative Procedures

- Add submittal requirements and approval criteria for development on single family and duplex existing lots of record and connection permits for model homes.
- Simplify the parameters used to determine when an erosion control permit is not required.
- Incorporate general housekeeping updates to reflect current practices and submittal requirements that facilitate District and City plan reviews.

Chapter 3, Sensitive Areas and Vegetated Corridors

• No changes proposed

Chapter 4, Runoff Treatment and Control

- New permit conditions require treatment for all development that creates or replaces 1,000 square feet or greater of impervious surface and prioritization of low impact development approaches (also known as green infrastructure). The changes to Chapter 4 incorporate the District's proposed approach to comply with this permit requirement.
- Based on stakeholder input, the proposed changes include revisions to the redevelopment requirements.
- General "housekeeping" changes include changing the term "facility" to "approach" for specific water quality and quantity types.

Chapter 5, Conveyance Systems

• No changes proposed

Chapter 6, Erosion Prevention and Sediment Control

- Provide a reference to the 1200-CN permit, in addition to the 1200-C permit.
- Add new Sediment Control BMPs for work in and near sensitive areas and a reference to a new manual currently being developed specific to erosion control for development in and near sensitive areas.
- Add a new requirement for Supplemental Plans as BMPs in limited instances.
- Add criteria for the use of chitosan to treat construction site runoff.
- Remove outdated inspection frequencies.

Chapter 7, General Construction Specifications for Conveyance Systems

• No changes proposed

Chapter 8, Technical Specifications for Conveyance Systems

• No changes proposed

Chapter 9, Wastewater Pump Stations and Force Mains

- Updates to materials to reflect new technologies and approaches
- Replace the reference to Treatment Plant Services with Wastewater Treatment Department

Chapter 10, Septic Tank Effluent Pump (STEP) Systems

Appendix B, Standard Details

- Revisions to existing details and addition of new details to reflect existing practice and current construction techniques and materials.
- Drafting changes are made to all drawings with the exception of details that will be considered during the Phase 2 update. The drafting changes standardize the layout to improve legibility, including font and hatch patterns that indicate different materials.

1	It appearing to this Board that the District has entered into intergovernmental agreements
2	with Washington County (County) and the cities within the District's boundaries primarily affected
3	by the District's master plans to provide for an integrated system pursuant to the District's master
4	plan for sanitary sewer and storm and surface water management, and that these agreements
5	provided that the cities and County will observe the orders promulgated by the District; and
6	It appearing to the Board that the Board, on April 17, 2007, adopted District Resolution and
7	Order No. 07-20, which repealed Resolution and Order No. 04-9 and adopted revisions to the
8	Design and Construction Standards pertaining to the sanitary sewerage and storm and surface water
9	management systems, including regulations for erosion control and protection of water quality
0	sensitive areas, pursuant to Ordinance 27; and,
1	It appearing to the Board that the Board, on August 5, 2008, adopted District Resolution and
2	Order 08-28 which amended provisions of Resolution and Order No. 07-20; and,
3 .	It appearing to the Board that the Board, on August 17, 2009, adopted District Resolution
4	and Order No. 09-25 which amended provisions of Resolution and Order No. 07-20; and,
5	It appearing the existing rules and regulations of the District contained in Resolution and
6	Order Nos. 07-20, 08-28 and 09-25 are in need of revision to maintain compliance with the
7	District's NPDES permit to increase flexibility, to clarify current policy and procedure, to improve
8	consistency in implementation, and to reflect new technologies and requirements necessary to
9	ensure proper function of sanitary, storm water and surface water management facilities; and
20	It appearing to the Board that the revised Design and Construction Standards serve to reduce
21	the adverse effects to water quality and quantity of any construction or site alteration and will
22	further safeguard the public health and safety and the operations of the District's sanitary and storm
23	and surface water systems, to aid the District in achieving compliance with the rules and
24	requirements of the Oregon Department of Environmental Quality, to coordinate the District's
25	planning and actions with the comprehensive plans of the cities and County as those entities comply
26	with title 3 of Metro's Urban Growth Management Functional Plan, and to further efforts to

1	improve the water quality of the Tualatin River and its tributaries; and
2	It appearing to the Board that the District has conducted an extensive outreach of public
3	information regarding the development and adoption of these rules, including meeting with
4	representatives of the cities within the District and with the County, and providing information and
5	copies of the proposed rules to those entities and members of the public; and
6	It appearing to the Board that the revised Design and Construction Standards (Standards)
7	were separately provided to the Board and a copy is available at the Clerk's desk; and
8	It appearing to the Board that it has conducted a public hearing regarding the adoption of
9	these Standards on this date in accordance with District Ordinance No. 27, Section 8 and that public
10	notice was given as required and interested persons were given an opportunity to appear and be
11	heard; and
12	It appearing to this Board that it is appropriate to adopt the Standards, that such Standards
13	are within the scope of District Ordinance No. 27 and are necessary to further the objectives of
14	District Ordinance No. 27, which include: enhancement and maintenance of the water quality of the
15	Tualatin River and its tributaries; compliance with state and federal permit and regulatory
16	requirements; promotion of the health, safety, and welfare of the community; and furtherance of the
17	objectives and purposes of the Federal Water Pollution Control Act 33 USC§§1251-1387; and the
18	Board being fully advised in the premises; now, therefore it is
19	RESOLVED AND ORDERED that the Standards are hereby adopted; and it is further
20	RESOLVED AND ORDERED that Resolution and Order Nos. 07-20, 08-28 and 09-25 are
21	hereby repealed, provided however that all permits issued, enforcement and other actions taken
22	pursuant to said Resolutions and Orders prior to the effective date of this resolution shall remain in
23	full force and effect; and it is further
24	RESOLVED AND ORDERED that the District or its designee shall review all development
25	plans and site assessments required by these Standards and specify in a certification letter to the city
26	or county responsible for land use review of the proposed development what conditions must be met

1	by the application in order for the District or its designee to issue a stormwater connection permit
2	pursuant to District Ordinance No. 27 and these Standards; and it is further
3	RESOLVED AND ORDERED that final stormwater connection permits shall be issued by
4	the District or its designee upon confirmation that the development approved through the land use
5	review or through other development permit process is consistent with the conditions required in the
6	certification letter or revisions thereto; and it is further
7	RESOLVED AND ORDERED that administration of the Standards may be delegated to
8	individual cities and to the counties as the District's designees only pursuant to intergovernmental
9	agreements that specifically provide for such delegation; and it is further
10	RESOLVED AND ORDERED that the General Manager is hereby authorized and directed
11	to take such steps as are necessary to finalize the Standards, including but not limited to correcting
12	typographical errors, removing "Reader Notes", and removing underline and strike-outs to produce
13	a final version that can be published and available to the public. These changes shall not affect the
14	substance of the Standards; and it is further
15	RESOLVED AND ORDERED that this Resolution and Order shall take effect for all
16	development and construction permit applications received on or after April 22, 2017, unless
17	specifically requested by applicants for development and construction permits with applications
18	currently in process. More specifically:
19	 New land use and building permit applications accepted by the land use authority on
20	or after April 22, 2017 must be accompanied by a Clean Water Services Service
21	Provider Letter dated on or after April 22, 2017 or one dated before April 22, 2017
22	which specifically references compliance with this Resolution and Order.
23	 Modifications to Service Provider Letters for land use or building permit applications
24	that were accepted by the land use authority before April 22, 2017 will be reviewed
25	and processed for compliance with the rules under which the Service Provider Letter
26	was originally issued.

1	Construction drawings submitted for Site Development and/or Erosion Control		
2	Permits will be reviewed under this Resolution and Order if initially accepted by the		
3	District/City on or after April 22, 2017; earlier submittals will be reviewed under		
4	Resolutions and Order No. 07-20, as amended by Resolution and Order Nos. 08-28		
5	and 09-25.
